# The Charlestown Marina Opens May 1, 2015

The grand opening of the new Charlestown Marina will take place on May 1 just in time for the 2015 boating season to begin. The owners of the marina, Ann and Chuck Lagasse are transforming the historic harbor setting from a state-condemned marina into a stateof-the-art facility. The Lagasses have 25 years of experience as marine operators. Upon completion, the three year construction project will include 350 single and double loaded slips on Piers 8 and 6, accommodating vessels from 25 to 400 feet. A full range of dockside services will be available such as metered electrical service, water connections, complimentary waste pump out, shower rooms, laundry facilities, grilling stations and complimentary Wi-Fi. To reduce wave and wake motion from the outer harbor a 900 foot breakwater system of hybrid steel/ concrete with Ipe wood decking has been installed. The breakwater has four million pounds of concrete to break the waves. The construction of the marina started with installing the docks at the shoreline rather than installing in the breakwater first to avoid disturbing the flounders mating season.

Opening for Season One (May 1 -October 31,2015) will be Pier 8 in front of the HarborView Apartments and The Shipway and Rowhouse Condominiums housing 250 slips for seasonal and transient boaters. Also part of the Season One phase is the opening of the Marina Office at Building 224 including bathrooms, showers and laundry facilities,

open paid public parking on both Piers 8 and 6 and the opening of the existing bulkhead docks at Pier 6 for transient boaters. Paid parking will be available on both piers for marina patrons and the general public. Seasonal pricing on Pier 8 is \$185 per linear foot for double loaded slips, \$205 per linear foot for T heads and \$225 per linear foot for single loaded slips. Transient pricing on Pier 8 is \$3 per linear foot per day for boats less than 50 feet and \$5 per linear foot per day for boats over 50 feet. The renovated Pier 6 slips are targeted to open in May 2016. Bosun's Marine will occupy many of the Pier 8 slips closest to the shore with a boat in water showroom open during business hours.

For many years the Harbor Walk has been a major concern of the residents living in the community and the restoration of the HarborWalk is an important part of the Lagasses' three year plan including replacing the wooden walk, installing lighting and railings. The restoration of the Harbor Walk will begin during Season One with a review of the plan with abutters and stakeholders and obtaining the necessary city and state permits required to restore the walk. Another concern of residents of the Navy Yard is the possibility of noise resulting from the docked boats. The Charlestown Marina owners, themselves dock people, are dedicated to running a safe well-run family marina. Dock staff will be available on both piers and security cameras will monitor all the premises. During the summer season

security guards will be hired to walk the marina all night. The marina regulations will follow the noise ordinance laws for the city of Boston requiring quiet from 11pm-7am.

The Charlestown Neighborhood Council Development Committee will hear a presentation by Ann and Chuck Lagasse of the Charlestown Marina with respect to the on-going development/ rehabilitation of the piers and marina located in the Charlestown Navy Yard. The meeting was held on April 8, 2015 at the Constitution Inn.



Wynn casino proposal and its effects on Charlestown, particularly the traffic impacts on Sullivan Square and how the City plans to get Wynn and the Gaming Commission to address those impacts. #### The Charlestown Marina: MEET THE TEAM

Husband and wife team, Ann and Chuck Lagasse began development of the new Charlestown Marina in Fall 2014. Community-minded with a history of recognizing the potential of undervalued or underused buildings and properties, they apply thoughtful, preservation sensitive approaches to reconstruction and transformation into quality buildings and properties.

The Lagasses have extensive experience in marina development having spent the last 30 years in redevelopment efforts in downtown Newburyport. There they restored and managed 35 downtown Newburyport mixed-use properties consisting of 300,000 square feet of retail, office, residential and commercial tenants, including five full service marinas and two restaurants. The City of Newburyport awarded numerous preservation awards to the Lagasses for their contribution to the waterfront, community and landscape over the past years. Prior to beginning the Newburyport Marina development Chuck founded and operated Plastek Corporation, a manufacturer of high technology plastic components plants in New England and the midwest. The Lagasses sold the Newburyport portfolio and Plastec in 2009 to focus on the development of waterfront properties in downtown Boston. They purchased Boston Yacht Haven Inn & Marina on Commercial Wharf and took it from bankruptcy to a thriving and vibrant marina. Stop by the Boston Yacht Haven and you will see this premium property to get a sense of what our Charlestown Navy Yard will become. In addition, the Lagasse's manage Fan Pier Marina in the Seaport District and founded and operate Harbor Fuels, a marine fuel business in East Boston.

Chris Giroux, dock master at Charlestown Marina, is a graduate of Massachusetts Maritime Academy. Chris started

working at Shipyard Quarters in 2005 as a dockhand during his high school summers. After college, he was hired as the dock master and had the difficult job of managing the deteriorating Shipyard Quarters marina which was ultimately was closed by the Commonwealth. The new owners of Charlestown Marina hired Chris in October 2014.

## Spaulding's Race for Rehab Team Running the Boston Marathon for Those Who Can't

Over the last 10 years, Spaulding has had over 250 runners raise over \$2.5 million for Spaulding as part of their Race for Rehab Boston Marathon program. This year, 52 runners will take part in the 119th Boston Marathon on Monday, April 20th on behalf of Spaulding.

Spaulding's Race for Rehab team each year is comprised of former patients, former patient's family members, Spaulding staff, community leaders and rehabilitation advocates.

For the runners, this winter has been especially hard, training through a tough New England winter, but with only a few weeks to go the finish line is their main goal.

## Starboard Place opening in April

Developed by the Kavanagh Advisory Group, Starboard Place will open for occupancy in late April. According to Shannon Lavin of the Ligotti Lavin Team real estate brokers for Otis & Ahearn this will be the first ground up new construction residential condominium building in the Navy Yard in a very long time. Starboard Place is designed to fit seamlessly into its historic setting, yet provides residents with an efficient, problem-free low maintenance building.

The development offers 54 luxury units with multiple floor plans available, including studios with separate sleeping areas, one bedrooms, one bedrooms + study, and two bedroom units. Residents enter their units through a solid 8' walnut door and the combination of 9' ceilings and windows spanning 7' and a neutral palette including brushed metal and stone finishes add to the contemporary design.

Pricing starts at \$400,000. Rental garage parking is available at building 199 for \$180/month. The building is pet friendly with on site manager available part time on weekdays and on-site bike storage. patient who did her rehabilitation at Spaulding following a skydiving accident that left her unable to walk. Each member of the Race for Rehab team is required to raise a minimum of \$5,000 with a team goal to raise \$500,000. The funds raised by the team will be used support programs and services provided by Spaulding.

The perseverance and dedication of Spaulding's Race for Rehab Boston Marathon team reinforces Spaulding's slogan, find your strength, a motivational testament to Spaulding's patients who are rebuilding their mind, body and spirit.

## **BRA Approves Charlestown Navy Yard Hotel**



First Avenue Hotel LLC has been granted Article 80 approval by the Boston Redevelopment Authority (BRA) to develop the Chain Forge Hotel, to be located within the BRA owned Chain Forge - Building 105, situated at 105 First Avenue in the Historic Monument Area of the Charlestown Navy Yard, according to Lee Nilsson Project Manager of the Kavanagh Advisory Group, LLC. "This exciting develop-



ment will clean and restore a historically significant, blighted and deteriorating structure located within a vibrant mixed use community." as described by Nilsson. The Kavanagh Advisory Group has just completed the Starboard Place condominium development project to open in April 2015 in the Navy Yard.

Chain Forge Hotel will be a five level hotel development, approximately 180,000 GSF in size, encompassing the entire current structure on site and adding an additional level of hotel rooms on the rear of the building. There will be approximately 230 hotel rooms within the hotel, with an associated hotel lobby area, conference rooms, pool, fitness center, restaurant, and historical exhibit showcasing the projects prior industrial uses. Nilsson indicated that a critical

component of the hotel redevelopment is the historical exhibit area located within the lobby atrium. The exhibit will allow public visitors and guests staying at the hotel to view 38 pieces of historical machinery owned by the United States

National Park Service, and retained onsite as an interpretive exhibition.

Parking for the Chain Forge Hotel and restaurant will be via a valet service operated by the hotel, and will utilize an off-site parking area within the Boston AutoPort located approximately 1/3 of a mile from the hotel. This exciting development will clean and restore a historically significant, blighted and deteriorating structure located within a vibrant mixed use community.



## USS Constitution, Charlestown Navy Yard Readying for Dry Dock Entry

Mass Communication Specialist 3rd Class Victoria Kinney, USS Constitution Public Affairs reports that after delays brought on by Boston's snowiest winter on record, USS Constitution is scheduled to enter Dry Dock 1 for a threeyear planned restoration period in the Charlestown Navy Yard in the early hours of May 19, 2015. USS Constitution, the world's oldest commissioned warship afloat, actively defended sea lanes against global threats from 1797 to 1855.

Old Ironsides' move into dry dock, originally slated for March 20, will now commence at approximately 12 a.m. on May 19. The docking evolution was selected for a midnight start due to favorable predicted tidal conditions in Boston Harbor. While the Constitution is in dry dock, visitors to Charlestown Navy Yard will have the rare opportunity of viewing the ship's entire exposed hull, including her fabled copper plating and keel comprised of original wood utilized during the ship's initial construction from 1795-1797.

Dry Dock 1 holds approximately 4.8 million gallons of water and takes approximately two hours to fill and 14 hours to empty. On June 24, 1833, Constitution became the first ship ever to enter the dock, which used a woodenconstructed caisson at that time.

From April 16 through April 26, Constitution will be shifting from winter to summer public tour hours: Open Tuesday through Sunday from 10 a.m. until 6 p.m. (closed on Mondays with the exception of Patriots Day on Monday, April 20). Beginning Monday, April 27, Constitution will temporarily close to the public while final preparations are made for entering dry dock on May 19. On June 9, once the ship is secure in Dry Dock 1, Constitution will reopen to the public with tour hours taking place Tuesday through Friday from 2 p.m. until 6 p.m., and Saturday and Sunday from 10 a.m. until 6 p.m. (closed Mondays).

The FCNY has been notified by the Navy that the noise from the diesel engines pumping the dry dock will occur at least one more time for testing between now and April 19th and then for the last time when the USS Constitution is moved to the dry dock.
